1. Summary

This appendix describes the deviations and exceptions for military use to the original CMA rule book.

1.1. Purpose

The CMA shooting sport is intended to offer both sport shooters and members of the armed forces the opportunity to measure their individual shooting skills as comprehensively as possible and within a sporting framework. For military use, there are some special possibilities, requirements and needs that differ from civilian use. This should be taken into account here. Furthermore, it should be avoided as far as possible that members of the armed forces acquire undesirable, possibly even counterproductive techniques or behaviors through the practice of CMA sports.

The civilian regulations of CMA will be replaced in the relevant points by those of the armed forces or by appropriate deviations.

1.2. Validity

The deviations and exceptions defined herein are to be used exclusively for events in which all participants are active armed forces service members or reservists.

If this appendix is applied for a CMA shooting event, this has to be clearly communicated beforehand.

The match director may determine individual exceptions for participation, such as invited guests. Guests must be properly trained in the relevant points of fundamental safety regulations, manipulations and handling.

Events with participants who are not appropriately trained are not permitted.

All specific deviations and exceptions are defined herein. All other points of the rules remain valid and unchanged.

2. Deviations

2.1. Muzzle Direction

Deviation from rule book 2.1 and 2.1.2

180° rule: When the shooter moves away from the main bullet trap, the muzzle of the gun may violate the 180° rule. The muzzle must be pointed in accordance with the relevant participating armed forces regulations for small arms shooting training.

Pointing at a person: Covering a part of the shooter's body with the muzzle can be tolerated if the manual safety is engaged and the rifle is carried in the correct military carrying style, for example in front suspended on a sling (also called front side hang or safe hang).

Barrel check: The barrel check is carried out by the shooting supervisor before shooting, if required by military regulations. The PSC (Personal Safety Check) and the unloading check is carried out according to CMA rules.

2.2. Safe Areas

Deviation from rule book 2.4.

Safe Areas: The concept of safe areas can be replaced by the implementation of the corresponding military regulations.

2.3. Carrying of rifles

Deviation from rule book 2.6. and 2.6.2.

Carrying of rifles: The rifles can be carried in accordance with military regulations.

2.4. Weapon Transition

Deviation from rule book 3.5. and 3.5.6.

Weapon transition: During and after the change from rifle to pistol, the rifle can be carried in front suspended on a sling, safety on, in accordance with military regulations (also called front side hang or safe hang).

2.5. Targets

Deviation from rule book 4.

Additional Targets: Targets may be used that comply with military regulations and allow a simple and clear scoring for hit (0 points) and no-hit (5 points).

In the case of reactive targets, the hit/no-hit scoring must be carried out immediately during shooting by at least one additional official assigned to this task.

This makes it possible to do stages with longer shooting distances and efficient scoring.

2.6. Categories

Deviation from rule book 5.2.

For military application, the following categories are defined as additional incentives:

Military	Uniform with weapon belt
Military Light	Uniform with weapon belt, empty plate carrier or chest rig
Military Full	Uniform with weapon belt, ballistic protection vest with all protective plates inserted
Military Heavy	Uniform with weapon belt, ballistic protection vest with all protective plates inserted and an additional package of at least 15kg

2.7. Distances

Deviation from rule book 6.3.

Distances: There is no limit to the shooting distance for the use of rifles in the Large Rifle division. All participants start in the Large Rifle division for distances over 100m.

2.8. Rifle Divisions

Deviation from appendix A1 3.1.

The service weapons may only be used in semi-automatic mode. If present, the mechanical automatic fire block is to be activated.

2.9. Equipment

Deviation from appendix A2

The entire appendix A2 is replaced by the applicable regulations for military equipment.

2.10. Skills Test

Deviation from appendix A31

The skills test for handgun and rifle can be done in any category (according to appendix B1 2.6).

The times for the classes remain unchanged.
